Bidders must submit their bid electronically upon a submission of scanned copy (pdf) of written application along with the copy of company/ firm registration certificate, VAT registration certificate and tax clearance certificate of FY 2076/077, should deposit the cost of bidding document **NRs. 3000.00** in the Office's Antarik Rajaswa Khata (account) as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Electronic bids must be submitted to the office of **Chaubise Rural Municipality, Rajarani, Dhankuta** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12.00 P.M.** on **2078/03/21 (2021/07/05)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2.00 P.M. on 2078/03/21 (2021/07/05)** at the office of **Chaubise Rural Municipality, Rajarani, Dhankuta**. Bids must be valid for a period of **90 Days** from the date of bid opening and must be accompanied by bid security amounting to a minimum of **69500.00** which must be deposited to Account No: **0700000841** on the behalf of **Chaubise Rural Municipality, Rajarani, Dhankuta** at **Nepal Bangladesh Bank, Rajarani Branch**, or same equivalent amount of bid bond authorized from a recognized "A" class commercial or financial institution eligible to issue bank guarantee as per prevailing law of Nepal. The Bid security amount stated above shall be valid for 30 days beyond the bid validity period.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Bid should comply in all respects with the instruction to Bidder included in the bid document no compliance with this instruction shall result in disqualification.
