Bids must be valid for a period of **45 Days** after bid opening and must be accompanied by scanned copy of the bid security in .pdf format which must be deposited to GA.3. Dharauti Account No: **22501017500019** on the behalf of Chaubise Rural Municipality at **Nabil Bank Ltd., Rajarani Branch**, amounting to a minimum of **as stated in bullet no. 1** or bid bond authorized from a recognized "A" class commercial or financial institution eligible to issue bank guarantee as per prevailing law of Nepal. The Bid security amount stated above shall be valid for 30 days beyond the bid validity period.
