The bids will be opened in the presence of Bidders' representatives who choose to attend at **2.00 P.M. on 2082/08/01** (2025/11/17) at the office of **Chaubise Rural Municipality, Rajarani, Dhankuta.** Bids must be valid for a period of **90 Days** after bid opening and must be accompanied by scanned copy of the bid security in .pdf format which must be deposited to GA.3. Dharauti Account No: 22501017500019 on the behalf of Chaubise Rural Municipality at Nabil Bank Ltd., Rajarani Branch, amounting to a minimum of **180000.00** or bid bond authorized from a recognized "A" class commercial or financial institution eligible to issue bank guarantee as per prevailing law of Nepal. The Bid security amount stated above shall be valid for 30 days beyond the bid validity period.
